If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. The buyers are advised to refer to the [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if the credentials of the service provider are validated on-line in GeM profile as well as validated and approved by the Buyer after evaluation of submitted documents.
4. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.
5. Past Experience of Similar Services: The bidder must have successfully executed/completed similar Services over the last three years i.e. the current financial year and the last three financial years(ending month of March prior to the bid opening): -
 1. Three similar completed services costing not less than the amount equal to 40% (forty percent) of the estimated cost; or
 2. Two similar completed services costing not less than the amount equal to 50% (fifty percent) of the estimated cost; or
 3. One similar completed service costing not less than the amount equal to 80% (eighty percent) of the estimated cost.

2. **Generic**

1. The Seller shall not assign the Contract in whole or part without obtaining the prior written consent of buyer.
2. The Seller shall not sub-contract the Contract in whole or part to any entity without obtaining the prior written consent of buyer.
3. The Seller shall, notwithstanding the consent and assignment/sub-contract, remain jointly and severally liable and responsible to buyer together with the assignee/ sub-contractor, for and in respect of the due performance of the Contract and the Sellers obligations there under.

3. **Buyer Added Bid Specific Scope Of Work(SOW)**

Text Clause(s)

I. SCOPE OF SUPPLY and REQUIRED SPECIFICATIONS

This tender encompasses the complete printing and supply of Coffee/Tea and Lunch coupons etc. for the Workers' Canteen. The awarded bidder shall be responsible for all aspects of production.

- a) The design and layout of the coupons will be based on the provided specimen copy (attached). The attached specimen copy serves as the guide for the design and layout of the coupons.
- b) The bidder may be required to provide a digital proof (soft copy by email) for approval before commencing the full print run.

- Ø Coupons shall be printed on A4 size 70 GSM color maplitho paper (as mentioned in the specification sheet).
- Ø Each A4 sheet shall contain 20 coupons, arranged for efficient cutting and distribution.
- Ø All coupons must be printed with a clear and consistent serial number.
- Ø The serial numbering needs to be sequential and without repetition.
- Ø Each A4 sheet must be accurately perforated to allow for easy separation of individual coupons.
- Ø Each book shall consist of 100 A4 sheets.
- Ø Books shall be securely bound using staple binding, ensuring durability and preventing loose sheets.
- Ø Printed coupon books shall be securely packaged to prevent damage during transportation.
- Ø The vendor shall be responsible for the timely delivery of the printed coupon books to the designated location.
- Ø The vendor shall be responsible for replacing any defective coupon book(s) without any additional cost.

II. ELIGIBILITY CRITERIA

Bidders must meet the following criteria:

- a. **Be an Indian company/firm engaged in supplying Photocopiers & spares of different specifications and having its Office (head office/ regional/Branch Office) in Bangalore.**
- a) **Have minimum one year of experience in providing service in printing work to the Departments/Ministries of the Government of India/PSUs/Autonomous Bodies and private institutions (Please attach at least one similar contract executed or ongoing in Bangalore, Karnataka.)**

- b. **Not have been blacklisted by the Depts/Ministries of the Govt. of India/PSUs/autonomous bodies(declaration has to be submitted in the specified format given in Annexure-I)**
