1. Let  $0 < \alpha, \beta$  and  $X_1, X_2, \dots, X_m$  be i.i.d. random variables with commmon probability density function with Weibull  $(\alpha, \beta)$ . Assume  $\beta > 0$  is a known constant. Find the maximum likelihood estimator for  $\alpha$ .
