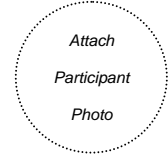

  - **Certified Black Belts** from recognized certified bodies.
  - Each candidate should have at least 6 years of experience in conducting/guiding improvement projects.

10. A participant will be issued an **Interim Master Black Belt Certificate** after
  - a) 100% attendance in the course, and b) Passing the MBB Test with minimum 70% marks.

*[This certificate will remain valid for next 18 months from the last day of the course].*
11. Any candidate failing to qualify the exam will be given another chance for writing the same along with the next program participants at no extra cost.
12. A failed candidate (refer 10) will not be issued any certificate.
13. The Interim Master Black Belt Certificate will expire after 18 months from the last date of the course.
14. A **MBB Card, as a mark of Completion of MBB Certification**, will be issued only after
  - i) **Guiding at least 5 projects** on improvement, **AND**
  - ii)
    - a) **Conducting 120 hours of training** in related topics, **OR**
    - b) **Attending 3 conferences/seminars/workshops** on related subjects

**within the following 18 months** [both (i) & (ii)].
15. If the proof of 14(i) and 14(ii) is not received **within 18 months** from the end of the course, the participant automatically loses the entitlement to receive a MBB Card.
16. Any participant applied for the program is understood to have gone through and accepted these terms and conditions.
